# Housing the Urban Poor: Policy, Planning and Implementation- Indian Experience

## (3 Weeks)

### December 4 to 22, 2023

---

#### COURSE RATIONALE

United Nations Universal Declaration of Human Rights embedded that access to decent, affordable housing is fundamental for the health and well-being of people as well as the smooth functioning of economies. At present across the globe, urban populations have increased rapidly, often outstripping available housing. This increasing rate of growth of urban population has led to increasing housing shortage, reducing privacy and overcrowding in small house, steady growth of slums and unplanned settlements and severe effect on civic services in urban areas. Embedded in such situation there is a critical need for adequate, safe, affordable and sustainable housing. Thus, provision of affordable housing has become one of the major tasks for many developing and under developed countries. This has further been recognized globally with the adoption of Sustainable Development Goals (SDGs) in 2015 and more recently the New Urban Agenda (NUA) at Habitat III Conference in October 2016 at Quito, Ecuador.

India, over its journey of 75 years after independence, India has made significant strides in urban development including in the provision of affordable housing. The Government of India and the State Governments in India have followed multipronged approaches to housing development and the same has evolved over the period of 75 years of independence. Starting with *site and services model*, where along with basic infrastructural facilities like water supply, sanitation, internal roads, drainage and construction assistance was provided, followed by *permanent housing model*, which was planned for households who could avail institutional finance. The development planning interventions in provision of affordable housing have since evolved to include emphasis on use of appropriate technology, affordable housing finance and private sector participation through *public-private partnership (PPP) models* in mission mode. **Pradhan Mantri Awas Yojana-Urban (PMAY-U), a flagship Mission of Government of India**, addresses urban housing shortage among the economic weaker section and low-income households by ensuring a permanent house to all eligible household. policy, planning and implementation aspects and also to share the Indian experience of one of the largest housing programmes, the **Flagship Programme in the mission mode- the Pradhan Mantri Awas Yojana-Urban, (PMAY-U)**.

### **OBJECTIVES OF THE COURSE**

The programme provides resources for understanding policy, planning and implementation aspects of a mega housing programme and enables participants to:

- Understand the policy frameworks required for National Housing/ Urban Policy;
- Understand the affordable housing issues, challenges and delivery strategies to meet the housing needs of all sections of society with a special focus on the economically weaker sections (EWS) and low-income groups (LIG);
- Define affordable housing for their country and its role in the making of affordable, inclusive, liveable cities;
- Analyse various challenges and aspects of affordable housing in their respective country;
- Policy, Planning and Implementation aspects of a mega housing programme;
- Understand various financing options/ models for affordable housing;
- Have an exposure through class-room study as well as the technical visits to project sites to gather a deeper understanding of field level issues and solutions;
- Draw learnings for the Flagship housing programme of the Government of India, i.e. the *Pradhan Mantri Awas Yojana- Urban* (PAMY-U)

### **EXPECTED OUTCOMES**

By the end of the course, the course participants should be able to:

- Understand various components of affordable housing;
- Have an understanding of the concept of affordable housing and understand its relation with other associated aspects like urbanization;
- Develop an understanding of policy measures and innovative practices in the field of affordable housing;
- Use planning tool- *Logical Framework for planning and Implementation* (Log Frame)
- Develop an understanding of various suitable financing options for affordable housing;
- Draw lessons from the Indian experience of the Flagship programme of the Government of India, the *Pradhan Mantri Awas Yojana -Urban* (PMAY-U).

### **TARGET GROUPS**

This programme has been specifically designed for policy makers, engineers, architects, town planners, urban designers, social scientists, finance professionals, community development professionals from the developing countries.

Participation of Non-Government Organizations (NGOs) as well as some elected representatives engaged in the housing sector shall strengthen the interaction among managers of urban development with special focus on affordable housing.

## **COURSE CONTENTS**

The course has been designed to be conducted as a learning workshop where participants will be expected to participate in the discussion through the mutual learning approach. A range of issues related to sustainable and affordable housing, various approaches, policy evolution, challenges, strategies with focus on developing a clear understanding of the key theme of the course, i.e. housing the urban poor. The programme will include guest lectures by domain experts, interactions with the policy makers and senior functionaries of the Government of India, action planning exercises and field visits to the project sites.

The course will have four modules and the themes to be covered are as under:

### **Module-1**

This module would introduce the concept of affordable housing, policy framework, evolution of policies, housing in the context of Sustainable Development Goals (SDGs) and the New Urban Agenda (NUA). This module will also include the following:

- Housing in the context of SDGs and NUA
- Evolution of the housing policies
- Housing typologies- slums, squatters, informal housing and formal housing
- Sharing of country presentations by participants

### **Module-2**

This module would focus on learning the tool- Logical Framework Analysis for planning and implementation:

- Learning the *Logical Framework Analysis for Plan formulation/ planning and implementation* (Log Frame)

- Log Frame: Stakeholder Analysis
- Log Frame: Problem analysis and problem tree
- Log Frame: Analysis of objectives and analysis of alternatives
- Log Frame: Completing the Log Frame (be able to use the tool for designing affordable housing programmes/projects)

### **Module-3**

This module would focus on the architectural and layout planning aspects and environmentally friendly building technologies:

- Architectural and layout planning aspects
- Environmentally friendly building materials and construction technologies

### **Module-4**

This module would focus on the learnings from the India experience of a Flagship housing programme of the Government of India, i.e. *Pradhan Mantri Awas Yojana-Urban* (PMAY-U).

- Detailed presentation on the various aspects of India experience of a Flagship housing programme of the Government of India, i.e. *Pradhan Mantri Awas Yojana-Urban* (PMAY-U).
- Interactions with the policy makers/ senior functionaries of the Ministry of Housing and Urban Affairs
- Learnings from the Flagship programme mentioned above.
- Technical visit(s) to the project site(s)
- Capstone sessions- Participants to make brief presentation on their learnings from the programme.
